Witness Statement in respect of case reference CV05P00514

I Johanna Dunne am writing to state my concerns for my grandson Nathan David Rafiq Domek, son of Peter Ivan Dunne and Urszula Domek

It has come to my attention that Urszula Domek still continues her barrage of untruths before the courts in relation to Nathan and my grave concern is to the emotional damage she is causing my Grandson I have since his birth observed certain patterns of behaviour with Urszula which continue to worry me regarding Nathan's welfare

Urszula's statement of 26 July 2002 claiming that my home is unsafe and that I leave medication in reach of Nathan are absolutely untrue

As a mother and grandmother I am acutely aware of child safety and have never left medication in reach of children

I have never in any way harassed or threatened Urszula contrary to her claims

I infact made myself available to Urszula to assist her in Nathan's care

I feel that the issues regarding Nathan need to be explored and I will gladly make myself available for interview to fully explain my concerns which I do not feel I can adequately express in this statement My concern is first for my grandson and his safety and welfare

I believe that Nathan has already been harmed by Urszula's extreme and unreasonable behaviour These concerns must in my opinion be addressed to prevent further harm to Nathan

On other substantive issues

My Son Peter has never been questioned or charged in relation to any ten year old child My Son has never behaved in a manner which would cause me concern with his care of Nathan or any child The extradition warrant used against my son Peter was clearly obtained by false and inaccurate information I was unaware of the allegations of Urszula Domek prior to my arrival in the UK today I have prepared this statement in Coventry, UK so as to comply with the orders of the court in respect of non-disclosure to Ireland

This statement is true and accurate to the best of my knowledge at this time In the interests of my grandson I await your prompt reply

I refer to your letter dated 26th Inst., and confirm that I have taken further instructions from the Gardai in relation thereto.

I enclose herewith further copy of the information which was sworn by Sgt. P.J. Whelan at Thomastown District Court on the 15th day of September 2003.

I also enclose herewith copy of the warrant to arrest which was signed by Judge William Harnett dated 15th day of September 2003. You will note that the information specifically refers to the offence as under Section 5 (1) of the Criminal Law (Sexual Offences) Act 1993 and the Warrant to arrest refers to the relevant Section and describes the offence as "Sexual Intercourse with a Person who was mentally impaired".

I also enclose herewith authorisation signed by A.E. Kennedy, Justice of the Peace together with Warrant of Commitment dated 21st day of October 2003.

The Garda Authorities have no knowledge of any issue which arose in relation to the age of the injured party and if your client wished to take issue in relation to the proceedings as conducted it was open to him to do so at the time.
